### 預防新型冠狀病毒肺炎 - 會議、講座、考試及同類型集體聚會的管理建議

Prevent Novel Coronavirus Pneumonia – Advice on the Management of Conferences, Lectures, Examinations and Similar Collective Events

In view that population gathering and face-to-face contact are important factors for the transmission of the novel coronavirus, this guideline is formulated with an aim to reduce the risk of spreading the disease during conferences, lectures, examinations and similar collective events.

## (I) Management of Participants

- 1.1. Perform crowd management by limiting the capacity of the venue to 50% of the normal capacity or below.
- 1.2. Take body temperature for all individuals entering the venue and require them to submit the Macao Health Code. Decline admission of any person presenting with fever or respiratory symptoms.
- 1.3. Require all participants to wear a mask in the venue at all times whenever possible, and maintain appropriate social distance. When not wearing a mask, a minimum distance of 1 metre should be maintained from others.
- 1.4. Should there be a large number of participants, it is advised to stagger the times of participants entering and leaving the venue; if conditions allow, it is recommended to adjust the entrance-exit according to practical situation in order to avoid overcrowding at the entrance-exit.
- 1.5. Line up participants in an open space with an arm's length distance apart from each other wherever possible upon admission.
- 1.6. Arrange separate spaces for different organizations to avoid intermingling of members of different organizations as much as possible.
- 1.7. Avoid arranging meal gatherings as far as possible; if inevitable, observe the measures stipulated in "Prevent Novel Coronavirus Pneumonia Advice on the Management of Group Catering Events".
- 1.8. A signage should be put up in the venue to remind participants to observe personal hygiene and not to assemble; advise assembling crowds to disperse or leave.
- 1.9. In event that a large number of participants feel unwell, notify the organizers and the Centre for Disease Prevention and Control of the Health Bureau.

Prevent Novel Coronavirus Pneumonia – Advice on the Management of Conferences, Lectures, Examinations and Similar Collective Events

- 2.1 Increase the frequency of cleaning and disinfection of equipment and articles in the venue, particularly the surfaces of tables, seats, toilets and frequently touched areas;
- 2.2 A distance of at least 1 metre should be maintained between seats; clean and disinfect them with 1:00 diluted bleach solution after each use.
- 2.3 Wherever possible, avoid sharing of equipment and tools; otherwise, clean and disinfect them with 1:00 diluted bleach solution after each use.
- 2.4 Toilets should be furnished with adequate liquid soap, as well as disposable paper towels or a functioning hand dryer.
- 2.5 Alcohol-based sanitizers should be made available wherever appropriate, particularly at the entrances to the venue, for use by attendees.
- 2.6 Maintain adequate fresh air supply indoors; if air conditioners are used, the fresh air and filtration systems should be maintained in good operation, cleaned and disinfected properly.
