This guideline shall be executed by relevant individuals and public/private entities under the supervision of their supervisory entities. Under article 3 (Obligation to cooperate) of Law no. 2/2004 – “Law on the Prevention, Control and Treatment of Infectious Diseases”, to achieve the target of prevention, control and treatment of infectious diseases, individuals and public/private entities are obligated to closely cooperate with their supervisory entities, and comply with the orders and guidelines issued by their supervisory entities according to the law. This guideline is without prejudice to any more concrete or stringent orders/guidelines set out by relevant supervisory entities in light of the actual circumstances.

In view that crowd gathering and face-to-face contact are important factors for the spread of novel coronavirus, this guideline is formulated to reduce the risk of spreading the virus in parks.

1. Management of facilities

- 1.1. Indoor public places should observe the “Prevention of Novel Coronavirus Pneumonia – Advice on the Management of Indoor Public Facilities”.
- 1.2. Warning signs should be erected in the park to remind visitors to observe personal hygiene, maintain a social distance of 1 metre or more from individuals other than their companions, and avoid assembly.
- 1.3. Strengthen cleaning and disinfection of the facilities in the park, particularly toilets and frequently touched surfaces.

2. Management of users

- 2.1. Regulate the number and flow of users entering the park and its outdoor public areas (such as child playground, basketball court, etc.). Suspend admission to the park/ facility when it is overcrowding and, wherever possible, ask users to line up in an open space at an arm's length distance apart from each other.
- 2.2. All individuals entering and staying in the park must wear a mask at all times except when removing it is necessary (e.g. while eating, doing physical activities of high intensity).
- 2.3. Always maintain a distance of at least 1 metre from non-accompanying persons.
- 2.4. Infants and young children should be under the care of their parents/ guardians at all times, and avoid close contact with other people in the park.
- 2.5. All collective activities or competitions should follow relevant anti-epidemic guidelines according to their nature.
